Quarter 1, 2005-2006 Programming Changes Implementation Date: September 1, 2005 REVISED: 8/25/2005

1. **Issue**: At the request of Mental Health Community Center Executive Directors a diagnostic qualifier will be added to the RDM children's assessment process. This new field will feed into the child/adolescent TRAG calculator to reduce the number of LOC-R=9.

Resolution: Identify DSM-IV Codes that will be used create a Diagnostic Qualifier List (see below). When one of the diagnoses listed on the Diagnostics Qualifier List is found as the primary diagnosis (Axis 1, Level 1) for a child/adolescent, display a new field, **DIAGNOSTIC QUALIFIER**, in Section 1: CA-TRAG. A drop down list will display with selection options: I=Internalizing, E=Externalizing, or N=Medication treatment Not yet stabilized. Programming will be added that will collect the data to be submitted to the CA-TRAG for LOC-R calculation.

- 2. **Issue**: Allow all discharges to be future-dated up to 30 days from the System date, except when Discharge Reason is:
 - J = Jail (for Adult)
 - J = TX Youth Commission (for Child/Adolescent), 2 = Residential Treatment (for Child/Adolescent following Treatment Foster Care) or 4=Court Ordered Juvenile Justice Placement (for Child/Adolescent following Treatment Foster Care).

Resolution: Change adult and children programming to allow for future dated discharges up to 30 days in advance.

3. Issue: For assessments subject to Medicaid Fair Hearings proceedings (Update Assessments ONLY) increase the timeframe allowed between the TRAG Date (Section 1, Adult; Section 1, Child/Adolescent) and the Authorization Date (Section 2, Adult; Section 3 for Child/Adolescent) from 14 day to 30 days when the new

"Subject to Medicaid Fair Hearings" Check Box is checked.

This box should only be checked when the effective date of a level of care has been delayed because the consumer is:

- Medicaid Eligible and
- The new level of care authorized will result in a reduction in either rehabilitative services or case management services and
- The individual is within the 10 to 14-day notification period specified by the Medicaid Fair Hearing requirements.

Resolution: Allow the timeframe between the TRAG DATE and the Authorization Date to be extended from 14-30 days on Update Assessments ONLY, when the

'Medicaid Fair Hearing Box' is checked.

ADD: "Subject to Medicaid Fair Hearing?" checkbox to allow the date timeframe extended from 14 days to 30 days. This will display on all assessments, but will be valid for update assessments only.

4. **Issue**: For Adult Section 2: LOCA – An adult assessment is NOT required to be open for H035, H036, and H050 mainframe CARE assignments. For H006, H029, and H030 CARE assignment codes, the date of the assignment must be on or after the latest Intake Assessment LOC-A Authorization Date.

Resolution: Change adult assignment programming to check CARE for RDM Assessments when assignments are added or updated. This change makes adult assessments function more like child/adolescent assessments.

5. Issue: Provide consistency between the adult and child assessment change the text on the Child & Adolescent Evaluation Assessment form/screen to Child & Adolescent Uniform Assessment.

Resolution: Change the text on the child/adolescent assessment form and screens to read: Child & Adolescent Uniform Assessment.
